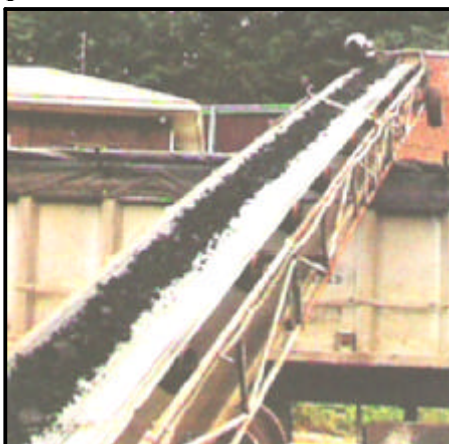


solids handling vehicles are available to ensure prompt pick-up and services.

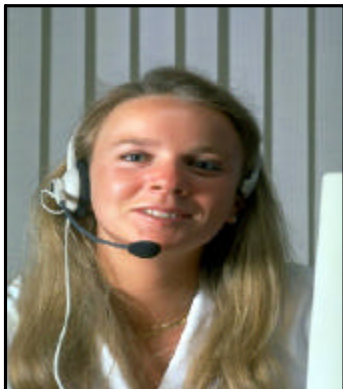

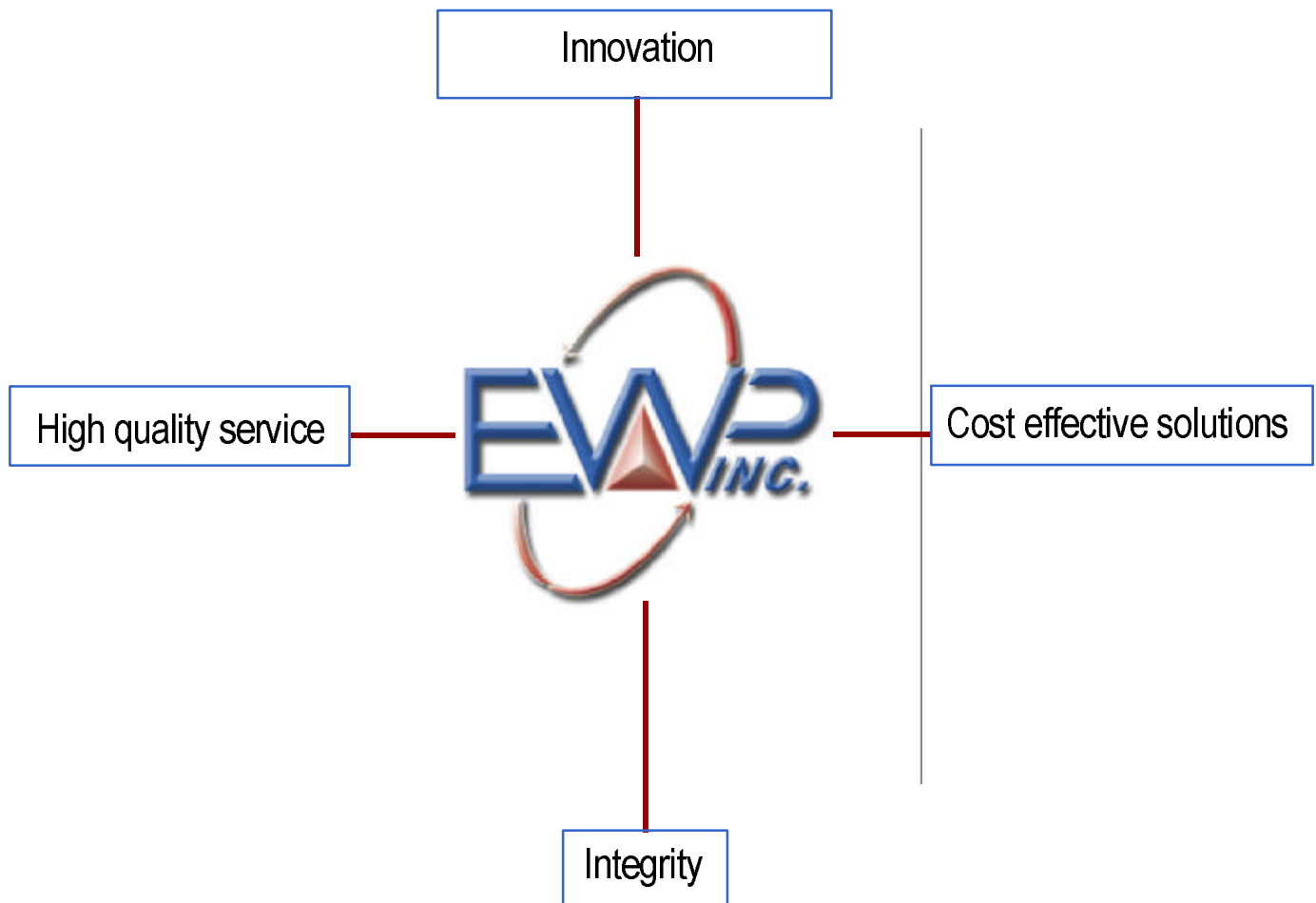
